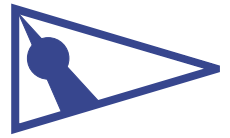




# 2010 Vanguard 15 Mid Atlantic Championships

### 1 RULES:

- 1.1 The regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS) and the Vanguard 15 class rules, except as any of these rules are changed by the Sailing Instructions or any appendices to the Sailing Instructions.
- 1.2 The regatta is designated Category C in accordance with RRS Appendix 1, ISAF Regulation 20.

### 2 RISK:

All competitors are ultimately responsible for the inherent risks associated with sailboat racing. It is the competitor's decision to enter the regatta and to start or continue any race. Each competitor will accept full responsibility for all his/her actions during any activity related to the event. This includes on-shore activities before, during, and after the regatta.

### 3 ELEGIBILITY:

Either skipper or crew must be a current 2010 Vanguard 15 Class Member. Yearly dues are \$15.00. Join on the National V15 site at [www.v15.org](http://www.v15.org) under the membership tab. The form will also be available at the regatta registration the day of the event if needed.

### 4 REGISTRATION:

Competitors may pre-register before Monday May 10th by one of two methods:

## **6 SAILING INSTRUCTIONS:**

## **7 SCORING:**

- 7.1 The Low Point Scoring System, Appendix A2, will be used except as modified below.
- 7.2 A minimum of two races must be completed to constitute a regatta.
- 7.3 Each yacht's score shall be the sum of all her races.

## **8 AWARDS:**

At a minimum, prizes will be awarded to first through third place.

### **Directions to Severn Sailing Association:**

From 95 travelling North to Maryland – Take 95 North to US-50 East Exit, towards exit 19A, towards Annapolis. Merge on to US-50 East. Take Md-70/Rowe Blvd exit, exit number 24, towards Bestgate Rd/Annapolis. Merge onto Rowe blvd. Turn slight left onto North West Street. Enter next roundabout and take 4 right onto Duke of Gloucester Street. Turn right onto Compromise Street. Compromise becomes 6 street. Turn at first light after bridge – left onto Severn Ave. Turn Left onto First Street. SSA will be at the end on the right.

From 95 travelling South to Maryland – Take 95 south to I-895 South Harbor Tunnel Thruway, exit number 62, on the left towards Annapolis/Bay Bridge. Merge onto I-895 Spur S. Take I-97 south ramp towards Annapolis/Bay Bridge. Merge on to I-97 South. Stay straight to go onto US-50 East. Take Md-70/Rowe Blvd exit, exit number 24, towards Bestgate Rd/Annapolis. Merge onto Rowe blvd. Turn slight left onto North West Street. Enter next roundabout and take 4<sup>th</sup> right onto Duke of Gloucester Street. Turn right onto Compromise Street. Compromise becomes 6 street. Turn at first light after bridge – left onto Severn Ave. Turn left onto First Street. SSA will be at the end on the right.
